- II. <u>Library Director's Report</u> (see attached)-Mark reported 2015-2016 holdings statistics. LD Mark working on set up as we are now an authorized Lincoln Center Local Screening site. LD Mark is serving on the SAPA Board of Directors and SAPA will be holding a training at the library in a few weeks. The Shakespeare group is enjoying Richard III and Bob & Judy Topolski have donated a Wii to the children's room. Upcoming events: Firearms history event, February 17th.

III. New Business

- a. Fundraising Committee report (see attached)-Cookie reported that a balance of \$69,410.39 Donor mailing has gone out and has been positively received. Kelly Murphy suggests doing two additional mailings targeted at two separate demographics and incorporating the concept of a match if we are able to secure a match anchor donor: 1. Second home owners in Weathersfield and 2. Residential tax base. LD Mark to talk with Town office to obtain lists and tentative timing for mailings will be end of February for Letter #1 and end of April for Letter #2. Kelly Murphy also reported on grant opportunities for furnishing the children's room and electronics. Kelly Murphy also presented the Board with an invoice which she wishes to gift in kind in recognition of Ernie and Cookie Shand's many contributions. Next meeting is scheduled for 03/01/2017 to continue planning Town Challenge which is scheduled for April 8, 2017. Planning for the Summer Evening with Friends event in July has started.

- d. CD Maturation -\$50,000 Construction CD matures at the end of January. Nancy made a motion to roll over the CD for 3 months. Ernie seconded and all voted in favor.. Anne to send minutes to Steve Hier to process the roll over.
